- 3. Pledge of Allegiance

There were no comments.

5. Review and/or approve Meeting Minutes: From May 3, 2018

M/s, Reed/Hillmer, to approve the minutes of May 3, 2018 as submitted. Ayes: All Absent: Hart Abstain: Przybylski

- 6. NEW BUSINESS
 - a. Adoption of FY 2018/19 Budget by Resolution

Executive Officer Weber presented a staff report.

Chair Finn thanked Executive Officer Weber for his work in stabilizing and finetuning the budget over the past couple of years. Executive Officer Weber referred to the ALS Back-up line item, in the amount of \$100,000, and stated it was reduced to \$62,500. The rest of the budget remains unchanged. There is an anticipated Fund Balance at the end of the year of around \$112,000. The current Fund Balance is \$793,000- \$100,000 is earmarked for the Equipment Replacement Fund and the rest is undesignated. It could be transferred to the Equipment Reserve Fund for purchase of an ambulance. The cost of a new ambulance would be anywhere from \$215,000 to \$260,000 depending on the type of chassis. This decision would be brought back to the Board in July.

Chair Finn mentioned the beneficial effect of capping the County Contract at a 3% increase. The Engine Medic Programs for Larkspur and Ross Valley were big ticket items- Larkspur budgets for seven paramedics and Ross Valley budgets for 10 paramedics. He referred to the ALS Back-up line item and stated

the City of Larkspur and the Town of Corte Madera continue their merger negotiations. Executive Officer Weber stated the Board could continue to discuss how to handle the Engine Medic Programs.

There were no comments from the public.

M/s, Hillmer/Przybylski, to adopt the resolution approving the Fiscal Year 2018-19 Budget as proposed by staff. Ayes: All Absent: Hart

b. Adoption of ambulance service fees by resolution

Executive Officer Weber presented a staff report. He noted staff was recommending that the RVPA more closely align with similar agencies in the region. Medicare and Medical local rates are based on a regional level. Staff is also recommending a change in some of the fee structures- the costs for an ALS and BLS transport are the same. He is asking the Board to strike the ALS 2 fee. There is a slight change in the mileage.

Chair Finn noted the RVPA base rate was \$200 below the average rate and it makes sense to get caught up.

Boardmember Reed supported the recommended change in the ALS/BLS rate since it would reflect actual costs.

There were no comments from the public.

M/s, Hillmer/Reed, to adopt the resolution approving the ambulance service fees as proposed by staff. Ayes: All Absent: Hart

c. Tax Renewal proposal for consideration by JPA member agencies

Executive Officer Weber presented a staff report. Staff is recommending an increase of \$4.00. Chair Finn stated the Finance Committee agreed that an increase of \$4.00 was sufficient for their needs. However, the fee does not have to go up by \$4.00 each year.

Boardmember Bailey thanked Executive Officer Weber and Chief Shurtz for their explanation of the spread sheet and the process.

Chair Finn stated each jurisdiction must take action in a timely manner to get this measure on the ballot.

Executive Officer Weber stated there was a question pertaining to the ballot argument- should the \$.50 administrative fee be included so it is charged to the parcel owner or should it be borne by individual agencies. County counsel is of the opinion that it is the responsibility of the parcel owner.

Chief Meagor had a comment about the fourth paragraph on the third page of the ballot argument.

Chair Finn reminded everyone to have the ballot arguments and reply arguments, if there are any, in hand and ready to go before the filing deadline.

Executive Officer Weber referred to page 4 of the staff report, the third bullet point, and asked about the following language: "...maintain rapid emergency response times...". Chief Meagor suggested the following: ..."maintain rapid emergency medical response...". The Board agreed with this language.

There were no comments from the public.

M/s, Reed/Przybylski, to adopt the Resolution subject to the County counsel's input on the administrative charge. Ayes: All Absent: Hart

- 7. OLD BUSINESS
 - a. Ambulance Billing Provider

Executive Officer Weber presented a staff report. He noted there was a benefit to using the services of Wittman Enterprises LLC since other agencies have also signed on with them. The proposal is 3.99% of net receivables, which equals about \$32,000. The prior arrangement with Wittman Enterprises was 5.65%. Staff also looked at whether it was better to bill per ticket or use a percentage. Staff decided on the latter. Executive Officer Weber stated staff was familiar with this company and Wittman Enterprises already has all the RVPA data and was familiar with the systems. He noted staff has received other quotes that were considerably higher.

Chair Finn asked if there was a deadline for completing the agreement. Executive Officer Weber stated staff would like to make the change by July 1st.

Chair Finn asked if there might be a problem getting the data from the former provider (Novato Fire) to Wittman Enterprises. Battalion Chief McTigue stated Wittman has the accounts ready to go- personnel lists, vehicle numbers, etc.

Boardmember Przybylski asked how long they were with the former provider. Executive Officer Weber stated since August 1, 2017.

There were no comments from the public.

M/s, Bailey/Finn, to authorize Executive Officer Weber to execute the agreement with Wittman Enterprises LLC as the ambulance billing provider and to allow him to make necessary changes to the language.

BACKGROUND

The current ambulance being used as the primary transport unit for RVPA has reached the end of its useful life. The current unit was remounted on a new chassis approximately 5years ago. The box has been in service for nearly 10years and served the JPA well.

DISCUSSION

We have reviewed options for purchasing a new ambulance including light to medium duty chassis vs commercial chassis. The assessment compares projected repair costs, original purchase costs and consideration of re-mounting the box on a new chassis in approximately five years.

STAFF RECOMMENDATION

Staff is recommending the purchase of a new ambulance on a 2019 Freightliner with a comfort ride system, passenger safety features including airbags. The total purchase cost is \$270,664.16 utilizing a public competitive procurement process through Houston Galveston Area Cooperative (HGAC). We will utilize the existing gurney and gurney lift system that will be re-installed in the new unit (Approx. \$50K value). Detailed information including the quote are attached for your reference. RVPA has a sufficient cash position to make this purchase without financing.
